NOTICE OF TITLE V PERMIT RENEWAL AND SIGNIFICANT MODIFICATION

NOTICE IS HEREBY GIVEN THAT CEMEX Construction Materials Pacific LLC, located at 25220 Black Mountain Quarry Road, Apple Valley, CA 92307 and 16888 North E Street, Victorville, CA 92392, has submitted applications to renew their Federal Operating Permit (100005) pursuant to the provisions of MDAQMD Regulation XII, in addition to applications for modifications to increase the Refused Derived Fuel hourly throughput limit condition for Kilns Q2 and Q3 at the quarry plant, the decommissioning of one belt conveyor and two belt vibrating screens to be replaced by two vibrating screens, the permitting of a new Limestone Feed System and additional cementitious material blending and load-out capabilities at the River Plant, the permitting of a new bucket elevator and air slide system over existing cement silos Group 3 resulting in increased capacity capability and improved cement loading at CEMEX – River Plant, and the reduction of allowable throughput from the non-retail above ground gasoline dispensing tank at CEMEX – River Plant. Applicant is a manufacturer of CalPortland cementitious products. The proposed actions will result in an increase in regulated air pollutants. The increase in nonattainment air pollutants are proposed to be fully offset.

REQUEST FOR COMMENTS: Interested persons are invited to submit written comments and/or other documents regarding the terms and conditions of the proposed renewal of CEMEX Construction Materials Pacific LLC's Federal Operating Permit. If you submit written comments, you may also request a public hearing on the proposed issuance of the Federal Operating Permit. To be considered, comments, documents and requests for public hearing must be submitted no later than 5:00 P.M. on December 21, 2024 to the MDAQMD, Attention: Daniel Concho, at the address listed below.

PETITION FOR REVIEW: Federal Operating Permits are also subject to review and approval by the United States Environmental Protection Agency (USEPA). If EPA has not objected to the proposed title V permit during its 45-day review period, the public may petition EPA to object to the proposed Title V permit within 60 days of expiration of EPA's review period. Any such petition must be based on objections that were raised with reasonable specificity during the public comment period unless the petitioner demonstrates either that it was impracticable to raise such objections within the comment period or that the grounds for the objection arose after the comment period. The petitioner shall provide a copy of such petition to the permitting authority and the permittee.
