BACKGROUND: In the effort to keep the Board familiar with the policies and practices which have been adopted to direct staff action and to facilitate the conduct of the business of the District, policies will be presented to the Board from time to time with recommendations for amendments if such are needed. The history and development of the policy is described in Exhibit 1.

The proposed version is in REDLINE form indicating the proposed changes from the current version. A final or "clean" version is also included. The format of the Governing Board Policy includes a signature line for the Executive Director which effectively acknowledges the Board's delegation of the Governing Board Policy.

REASON FOR RECOMMENDATION: Governing Board action is necessary to approve changes to the policies of the Governing Board.

Governing Board Policy 02-01 is the Governing Board Policy that directs the APCO to establish and maintain certain fund balances to ensure sound fiscal management of the District's resources. This policy was adopted on April 22, 2002 on recommendation of the Governing Board Finance Committee to memorialize a Board action recorded on August 25, 1997 to establish a designated cash reserves and reserves to address the liability associated with employee's accrued leave time, also known as compensated absences. On January 24, 2011 the policy was revised to remove the requirement for a Compensated Absences Reserves, which had been allocated to establish the OPEB Trust Fund. The last revision to Governing Board Policy 02-01was adopted On June 11, 2012 when the policy was reformatted and expanded to comply with GASB 54 requirements which required that the policy further classify the District's fund balance and provide descriptions for appropriate use.

Recommended Revisions

This revision cleans up and updates the policy language to more closely represent the evolving dynamics of financial reporting for government entities. In addition, the revision redesigns the Cash Reserve designations:

- 1. A Cash Reserve will be designated from the General Fund's unassigned fund balance at not less than 20% of the combined Personnel and Expenses from the annual adopted budget;
- 2. From this designation, an Operating Cash Reserves will be reserved in an amount not less than 10% of the combined Personnel and Expenses from the annual adopted budget;
- 3. The **remaining amount** of the designated Cash Reserves may be allocated for specific purposes and to accomplish strategic goals.
- 4. The policy now includes descriptions for four specific Reserves: Capital Improvement; Legal and Litigation; Compensated Absences; and Budget Stabilization.

The descriptions for designated Reserves may be revised or additional designations established, as required, by resolution adopting the budget or minute action. The Governing Board may authorize use of the Cash Reserves by resolution adopting the annual budget, or by minute action.

In addition, the policy authorizes that at the direction of the Governing Board reserve funds can be deposited in a high yield interest bearing account.

POLICY:

It is the policy of the Governing Board of the Mojave Desert Air Quality Management District (District) to direct the Air Pollution Control Officer (APCO) to <u>define and designate financial resources by</u> establishing and maintaining certain <u>reserve funds balances</u> to ensure the sound fiscal management of District resources. This policy is <u>designed to conforms</u> to Government Accounting Standards Board Statement No. 54 (GASB 54).

AMPLIFICATION OF POLICY:

A. General

The District believes that sSound financial management principles require that sufficient funds resources be retained by the District to provide a stable financial stability for day to day operations. base at all times. To retain this stable financial base, the District needs to maintain An unrestricted fund balance in its funds provides sufficient to fund cash flows of for the District and and to provides financial reserves to minimize adverse budgetary impacts from for unanticipated expenditures and/or revenue shortfalls-of an emergency nature. All funds designated eCommitted, and Assigned, and the unassigned fund balance, as defined herein, in the General Fund are is considered unrestricted.

The purposes of the District's fund balance policy include maintaining prudent level of financial resources to protect against reducing service levels or raising fees because of temporary revenue shortfalls or unpredicted one time expenditures. Another purpose is to reserve funds for unanticipated large expenditures, such as capital expenses; or extraordinary costs associated with defending the District's regulatory activities.

Operating Cash Reserve

It is the policy of the Governing Board of the MDAQMD to achieve and maintain an unrestricted fund balance in the General Fund The APCO shall establish and include in the annual operating Budget of the District an Operating Cash Reserve of not less than ten percent (10%) of the combined budget categories of Salaries and Benefits, Services and Supplies and Transfers to Debt Service. In no case shall the Operating Cash Reserve be less than \$500,000.

2. Budgetary Reserves

Any reserve identified by line item in the District's most recently adopted budget. These will usually be identified in the budget as "Assigned Fund Balance" and use of these funds is subject to the appropriate authority as determined by policy.

POLICY:

It is the policy of the Governing Board of the Mojave Desert Air Quality Management District (District) to direct the Air Pollution Control Officer (APCO) to define and designate financial resources by establishing and maintaining certain reserve funds to ensure the sound fiscal management of District resources. This policy conforms to Government Accounting Standards Board Statement No. 54 (GASB 54).

AMPLIFICATION OF POLICY:

A. General

Sound financial management principles require that sufficient resources be retained by the District to provide stability for day to day operations. An unrestricted fund balance provides cash flow for the District and provides financial reserves to minimize adverse budgetary impacts from unanticipated expenditures and revenue shortfalls. All funds designated Committed, and Assigned, and the unassigned fund balance, as defined herein, in the General Fund are considered unrestricted.

B. Classification of Funds

The following classifications conform to GASB 54. Examples are provided to illustrate how the classification might be used in practice.

1. **Nonspendable Fund Balance** includes amounts that are not in spendable form (tangible assets such as property, inventory), or are required to remain intact, and will never convert to cash. The District is likely to report these as Capital or Fixed Assets.

- 2. **Restricted Fund Balance** includes amounts that can be spent only for the specific purposes stipulated by the external source, government code, enabling legislation, or other legal restriction. The District is likely to establish separate trust funds for these funding types; for example: Mobile Source Emission Reduction Revenue (AB 2766), and Carl Moyer Grant Program Funds are held in separate trust accounts and are reported separate from the District's General Fund. This category could be further distinguished as follows:
 - a. Special Revenue Funds. Special revenue funds are created to account for the proceeds of specific revenue sources that are legally restricted to expenditure for specified purposes.
 - b. Debt Service Funds. Debt service funds contain specific debt reserve amounts that are subject to the requirements set forth by the ordinances or resolutions that authorize the issuance of debt. It is the District's policy that debt reserve requirements for any outstanding debt issue will be consistent with the resolution authorizing the issuance of debt.
- 3. **Committed Fund Balance** are designated and described by specific policy and includes amounts that can be used only for the specific purposes determined by a formal action of the Governing Board. Commitments may be changed only by action of the Governing Board. The District's Operating Cash Reserves, as established by C.1. below, is an example of this classification.
- 4. **Assigned Fund Balance** is used to describe the portion of the fund balance that reflects the intended use of resources; the intent being established by the Governing Board, or the Board's designee. From time to time the Governing Board may establish other designations of the fund balance.

- C. <u>Designating Specific Reserves from the Unassigned Fund Balance:</u>

RECOMMENDATION: 1) Award an amount not to exceed \$339,948.80 from the Mobile Source Emissions Reduction Fund Pool to CalPortland Company to replace a 1987 Trackmobile 9TM with newer, cleaner engine technology; and 2) Authorize the Executive Director/APCO and staff to negotiate target time frames and technical project details and execute an agreement, approved as to legal form by the Office of District Counsel.

SUMMARY: This item awards grant in the amount not to exceed \$339,948.80 using funds from the Mobile Source Emissions Reduction Fund Pool to replace one (1) piece of equipment.

CONFLICT OF INTEREST: The parties to this agreement(s) will be the District, District Board members and officers and CalPortland Company with its principals and agents.

BACKGROUND: Assembly Bill 2766 authorized MDAQMD to impose up to a \$4 motor vehicle registration fee per vehicle licensed within the State of California to provide funds for air districts to meet responsibilities mandated under the California Clean Air Act (CCAA). AB 2766 states that the fees shall be used to support district operated planning, monitoring, enforcement and technical studies necessary to implement the CCAA. The Mobile Source Emissions Reduction Program is funded in part by these fees collected on motor vehicle registrations.

MDAQMD received a grant application from CalPortland Company to replace a 1987 Trackmobile 9TM. This project is an excellent candidate for the use of these funds. In upgrading their equipment, the District expects to see a reduction in NOx, ROGs and PM emissions. It is the recommendation of the District to approve the project as the emission reductions achieved will help improve the air quality in the District and the Oro Grande community.

SUMMARY: This item approves the Investment Selection for the PRSP, adopts the updated Investment Guidelines Document (April 2019), and authorizes the Executive Director/APCO, or designee, to execute required documents, subject to review by District Counsel.

CONFLICT OF INTEREST: Public Agency Retirement System (PARS), U.S. Bank, HighMark Capital Management, respectively their Directors and Officers; Governing Board members and officers of the MDAQMD.

BACKGROUND: On January 23, 2017 the Governing Board adopted Resolution No. 17-02 approving the adoption of the Public Agencies Post-Employment Benefits Trust. The action administratively combined the OBEP Trust and the Pension Rate Stabilization Program (PRSP), but kept separate the investment strategies and earnings for each Trust. These Trusts were established to address the District's liabilities associated with other post-employment benefits (OPEB) and pension benefits. Separate Investment Guidelines Documents (IGD) are in place for the OBEP and the PRSP which govern the investment process, goals, objectives, and overall management of the investment strategy for the each portion of the trust.

This action will authorize changing the investment strategy for the PSRP from "Moderately Conservative" to "Moderate" under the High Mark Plus Active portfolio. The three-year annual returns for the Moderate selection is 4.96% compared to the Moderately Conservative selection which is 3.81%. The Trust Administrator and Consultant has advised that this change will enhance investment earnings without negatively impacting the conservative investment goals. The "Active" selection uses Mutual Funds compared to the optional Index Plus method which uses Exchange Traded Funds.

Scope and Purpose

The purpose of this Investment Guidelines Document is to:

- Facilitate the process of ongoing communication between the Plan Sponsor and its plan fiduciaries;
- Confirm the Plan's investment goals and objectives and management policies applicable to the investment portfolio identified below and obtained from the Plan Sponsor;
- Provide a framework to construct a well-diversified asset mix that can potentially be
 expected to meet the account's short- and long-term needs that is consistent with the
 account's investment objectives, liquidity considerations and risk tolerance;
- Identify any unique considerations that may restrict or limit the investment discretion of its designated investment managers;
- Help maintain a long-term perspective when market volatility is caused by short-term market movements.

Investment Objectives and Constraints

The goal of the Plan's investment program is to generate adequate long-term returns that, when combined with contributions, will result in sufficient assets to pay the present and future obligations of the Plan. The following objectives are intended to assist in achieving this goal:

- The Plan should seek to earn a return in excess of its policy benchmark over the life of the Plan.
- The Plan's assets will be managed on a total return basis which takes into consideration both investment income and capital appreciation. While the Plan Sponsor recognizes the importance of preservation of capital, it also adheres to the principle that varying degrees of investment risk are generally rewarded with compensating returns. To achieve these objectives, the Plan Sponsor allocates its assets (asset allocation) with a strategic perspective of the capital markets.

Investment Time Horizon: Long-term

Anticipated Cash Flows: Assets in the Plan will seek to mitigate the impact of future rate

increases from SBCERA. Typically increases in rates come with a one-year advance warning; however this Plan may transfer

assets to SBCERA at any time.

Investment Objective: The primary objective is to generate a reasonable level of

growth. The assets in this Plan will eventually be used to fund Pension Plan obligations for assets managed in the SBCERA Trust. The assets in this Trust are also available to mitigate the potential negative impact of future rate hikes from SBCERA.

Risk Tolerance: Moderate

The account's risk tolerance has been rated moderately conservative, which demonstrates that the account can accept some price fluctuations to pursue its investment objectives.

Additionally, Health & Safety Code §40802 allows air districts with a population of 750,000 to appoint any person to a specialized position if no person with appropriate qualification is willing and able to serve. The MDAQMD has a population of less than 750,000.

The District has actively recruited for the Public Member vacancy since April 2018. The District received one qualified application for this position and staff recommends that Mr. Jerry Kinkade be appointed to fill the position.

This appointment is for a three-year term and will expire April 22, 2022. It is the intent of the Governing Board that the Hearing Board members shall, upon expiration of their terms, continue to serve in their previously appointed positions in an interim capacity until such time as the Governing Board makes a subsequent appointment to the applicable positions.

Glossary of Terms and Definitions

<u>AB 1</u>34

The AB 134 grant was developed by the California Air Resource Board (CARB) and CARB is providing Greenhouse Gas Reduction Funds through the Carl Moyer Program to support early actions that reduce emissions and improve public health in communities with high burdens of cumulative pollutant exposure, consistent with the goals of Assembly Bill 617 of July 26, 2017. This is a one-time grant in the amount of \$776,250.00 but additional funding may become available in the future

AB 2766

Authorized the Air District to impose a \$4 motor vehicle registration fee to provide funds to meet the new responsibilities mandated under the California Clean Air Act. The District approximately allocates \$600,000 for eligible projects on a yearly basis.

Carl Moyer Memorial Air Quality Standards Attainment Program (Carl Moyer Program)

The Carl Moyer Program was created by CARB and its goal is to reduce emissions by providing grants for the incremental cost of cleaner heavy-duty vehicles and equipment such as on-road, off-road, marine, locomotive stationary agricultural pump, forklift, and airport ground support engines. The District historically receives approximately \$600,000 for eligible projects on a yearly basis.

CRE Specialist Martial Haprov represented the District at the annual So Cal Gas Co. barbecue in Blythe on April 10 and the Blythe Outlook Conference on April 11. During the visit, Martial met with Palo Verde Valley Times Editor Uriel Avendano about establishing effective lines of communication for District news and alerts for better outreach in the Palo Verde Valley.

Internships

The District is currently recruiting for two interns – one in operations and one in Community Relations and Education. The interns must currently be enrolled in a community college or university in a field related to the internship they are applying for and will earn credits as a part of the program.

School Presentations

CRE Specialist Martial Haprov presented air quality fun facts to third graders at Maple Elementary School on April 4. The presentations (three sessions with approximately 45 students in each session) included an introduction to air pollution risks and helped increase awareness of the poster contest.





RE: April 2019 Legislative Report

Below, please find our April Legislative report.

As a result of our ongoing review of California bills on behalf of the District, we have identified eight bills that at least for now have been added to the Districts watch list. These are listed here with brief comments and we invite the readers to review more details on these bills in the list below.

- AB 939 deals with public notification requirements and may have implications to the District.
- AB 1143 by Assemblymember Quirk proposes to require Natural Gas utilities to provide to the state a portion of revenues collected from customers charged to cover compliance costs associated with California GHG regulations to help cover new programs.
- AB 1237 requires an agency that receives funds from the GHG fund to account for how that money is spent.
- AB 1388 calls for additional funding for forestry management to help reduce emissions associate with wildfires.
- AJR7 encourages the Federal Government to adopt the "Green New Deal".
- SB 236 establishes a new grant program to assist entities in developing new low-carbon technologies. There may be such entities in the District that might be interested in participating should the bill pass.
- SB 279 dealing with the High Speed Rail project is added only because at one point the new governor indicated his interest in cutting back on the program only to rescind that position in subsequent comments.
- And SB 732 is added because the is bill specific to the South Coast AQMD and we felt would be of interest.

With the addition of these bills, the Districts watch list now totals 68.

The reader should also note that due to significant amendments, there are now a few bills in this report we feel should no longer be of interest to the District. AB 254, originally dealing with the Air Resources Board, now deals with dishwasher effluent and will be removed from future reports. AB 1038 has also seen significant amendments and now, rather than applicable to Air Districts, deals with Health Care. AB 1056, also previously dealing with the Air Resources Board, now deals with residential speed laws.

We will continue to watch these bills however we will remove them from future reports unless amendments warrant inclusion. Seeing complete subject matter changes in the legislative process provides a lesson that any bill that initially may not can seem on interest can be amended to something completely different.

And a few additional notes:

- AB 126 no longer references the Carl Moyer program.
- Industry continues to be concerned about AB 315 3rd party verification requirements and are eager to see whether amendments provide some relief from those requirements.
- Ab 394 (Obernolte) seeking CEQA relief for forest fire safety is a commons sense proposal and should garner support.
- AB 423, specific to San Diego APCD and internet coverage, should be reviewed to determine whether the proposed requirement might be applicable to the District.
- Bonta's bill AB 966 has seen some minor amendments and the bill remains of concern to the cement industry. The industry continues to work closely with the author and other parties to alleviate such concerns.

Summary: Would require the State Department of Public Health to consider a report from a laboratory of an employee's blood lead level at or above 20 micrograms per deciliter to be injurious to the health of the employee and to report that case within 5 business days of receiving the report to the Division of Occupational Safety and Health. The bill would further provide that the above-described report would constitute a serious violation and subject the employer or place of employment to an investigation, as provided, by the division, and would require the division to make any citations or fines imposed as a result of the investigation publicly available on an annual basis.

Notes 1: Assuming it might be possible that high lead levels in blood might be caused by an air source, this bill might be of interest to the District.

Summary: Would authorize the Public Utilities Commission (PUC) and the State Energy Resources Conservation and Development Commission (Energy Commission) to jointly establish the California Clean Electricity Authority, a nonprofit, public benefit corporation, if both commissions make certain findings. The bill would authorize the authority to undertake procurement of electricity on behalf of retail end-use customers of electrical corporations, community choice aggregators, and electric service providers, collectively referred to as load-serving entities, and local publicly owned electric utilities, in support of certain energy, environmental, economic, public health, and public safety policy objectives.

Notes 1: Assembly-member Garcia has amended his bill that previously would have allow the state to procure electricity on behalf of California customers. The bill still allows for such procurements, but on a much more limited basis.

Summary: Would require the State Water Resources Control Board to take specified actions relating to microfiber pollution on or before July 1, 2020, and would require the state board to identify best practices for clothing manufacturers to reduce the amount of microfibers released into the environment. The bill would require, on or before January 1, 2020, a public entity that uses a laundry system, and a private entity that contracts with a state agency for laundry services, to install a filtration system to capture microfibers that are shed during washing.

Notes 1: Although not necessarily an air bill, considering the increasing concern regarding plastic contamination, we are including this bill in the District's list.

Summary: The California Alternative Energy and Advanced Transportation Financing Authority Act authorizes, until January 1, 2021, the California Alternative Energy and Advanced Transportation Financing Authority to provide financial assistance in the form of a sales and use tax exclusion for projects, including those that promote California-based manufacturing, California-based jobs, advanced manufacturing, reduction of greenhouse gases, or reduction in air and water pollution or energy consumption. The act prohibits the sales and use tax exclusions from exceeding \$100,000,000 for each calendar year. This bill would extend the authorization to provide financial assistance in the form of a sales and use tax exclusion for qualifying projects until January 1, 2031, and would

By imposing conditions on the reuse of water from a warewashing machine, the violation of which would be a crime, this bill would impose a state-mandated local program.

Notes 1: Originally this bill referenced issues associated with the California Air Resources Board but now deals with washing machine effluent. We may temporarily remove this bill from the Districts list but we continue to watch it.

Summary: Would create a 5-year woody biomass rural county collection and disposal pilot program, to be administered by the department, consisting of awarding funding to participating counties with a total population of less than 250,000 for the purpose of conducting community collection days at which individuals can dispose of woody biomass free of charge. The bill would require a county awarded funding under the program to contract with a local biomass conversion facility to collect and convert the biomass in a way that results in fewer greenhouse gases emitted than if the biomass had been disposed of.

Summary: Would, until January 1, 2025, exempt from CEQA egress route projects or activities undertaken by a public agency that are specifically recommended by the State Board of Forestry and Fire Protection that improve the fire safety of an existing subdivision if certain conditions are met. The bill would require the lead agency to hold a noticed public meeting to hear and respond to public comments before determining that a project or activity is exempt. Summary: Would provide that it is the intent of the Legislature to enact future legislation to establish the Climate Change Catastrophe Compensation Fund, the purpose of which will be to ensure that victims of wildfires caused by climate change are compensated in a timely manner, to provide reimbursements to insurers for a portion of those wildfire losses, and to avoid lengthy legal proceedings.
