Agenda Item 16 – Reports:

Special notes from Mr. Poiriez:

- ❖ California Legislature outlook: the Legislature convened the second year of the 2021-2022 Legislative Session on Monday, January 3rd. January 31st is the deadline for bills introduced last year to be out of their house of origin (two-year bills) so there are committee hearings and floor sessions to take up those bills. Bill introductions began on January 3rd for this year's Session. February 18th is the bill introduction deadline; Another deadline of interest is the last day to submit bill requests to Legislative Counsel for drafting, which is January 21st. Most bills will be taken up in March and April. The deadline for policy committees to pass bills that may have a fiscal impact (most bills do) introduced in their house is April 29th, so this is a significant deadline. May 6th is the deadline for policy committees to pass non-fiscal bills. It's an election year for all Assembly Members, half of the Senators and the Governor, so that will influence the dynamic at the Capitol. Making matters even more interesting are the new legislative and congressional maps.
- ❖ Jan. 10th Governor released his 22/23 first draft budget with estimated \$31-45B in surplus.
- ❖ Also, this month the Governor extended provision of AB361, regarding remote meetings due to increase in COVID numbers it allows remote meetings to continue through end of March

- currently.
- ❖ Jan. 19th: We were notified from EPA that MDAQMD was successful in being selected for the national TAG (Targeted Airshed Grant) for the second consecutive year. We were awarded \$1.1M project to fund 3 Electric School Buses for Adelanto. This will bring their total to 6 EV buses, and their infrastructure is complete that can charge up to 10 EV buses. Congrats to Jorge that has been aggressive in working with CARB and EPA on applications to submit for this highly competitive grant stream.

Mr. Poiriez updated the Board of past events:

- ➤ Jan 3rd 5th: Participated in the CAPCOA Board of Directors Board meeting: Items included: outlined 2022 goals, met with Smart Fueling Coalition, discussed CARB GDF Technical guidance, all things AB617, Air Shelter and Prescribed Fire grants. Full day meeting with CARB Executive staff, items included: Collaborative opportunities with Governor, new EPA Region IX Administrator; Mobile Source Strategy Implementation updates, AB617, Grant programs and Funding allocations; SIP contingencies, Regional Exceptional Events, CARB training program; and more.
- ➤ Jan 10th: Had a call with CARB on the Western Mojave Desert SIP.
- ➤ Jan. 12th: Participated in call with CARB and CAPCOA Mobile and Grants Committee on district roles in implementing the new SORE legislation and CARB regulation. Districts have concerns with how earmarked grant funds will accessed and distributed and what role Districts will have in the program.
- ➤ Jan. 18th: held AVAQMD Board meeting; gave updates on the status of the SORE program.
- ➤ Jan. 19th: Participated in a call with Assemblyman Eduardo Garcia with EO of SCAQMD and ICAPCD from a southern California perspective. Topics AB617 need legislative and policy changes, funding dwindling no designated funding stream for future years, AB8 (Carl Moyer) reauthorization, SORE program, potential for CARB Board members to be more engaged. Will have follow up with the Assemblyman and Lauren Sanchez from Governor's office in coming weeks.
- ➤ Jan. 19th: Participated in the MEEC Board meeting.
- ➤ Jan. 20th: Participated in AAPCA Air Directors monthly meeting.
- ➤ Jan. 24th: Earlier met with the Personnel Committee to give them an update on all the personnel movement and transitions that the MDAQMD and AVAQMD are experiencing.

Mr. Poiriez updated the Board of coming events:

- ➤ Continued calls with EPA Region IX regarding process and strategies for addressing recent/pending court rulings that EPA failed to act timely on submitted SIPs, Contingency Measures in SIPs, and continued discussions on 185 Fee rules and NSR SIP progress. A lot going on here.

- ➤ Feb. 9th 10th: CAPCOA Board mtg (virtual).
- Feb. 16th: MEEC Board mtg.
