Agenda Item 15 – Reports:

Miscellaneous:

- Continue to work on the compliance issues facing Nursery Products (Hawes Compost facility) near Hinkley. We are working and cooperating with other local and state agencies.
- This year's annual LGEE program is coming to a close on June 30th. As of last week, we had exchanged 327 pieces of equipment and expect to finish closer to 400. Very successful year.
- The board just approved a consent calendar item on today's agenda authorizing projects under the Carl Moyer/FARMER/CAPP grant funds totaling almost \$6.4 million dollars for the coming cycle – believe this is the most in a single year grant funding. Kudos to Jorge/Truong of Support Services and Grants.

Mr. Poiriez updated the Board of past events:

- June 14th: AB2836 (Garcia) Moyer bill passed the Senate Transportation Committee by 14-0 vote, had bipartisan support. Submitted our third letter of support to the Senate EQ on June 16th; on June 26th it passed with a bipartisan 7-0 vote. On to Senate Appropriations (last committee) waiting for scheduled hearing but probably sometime in August. All great news!
- > June 15th: Participated in the AAPCA local government call
- > June 16th: Participated in the AAPCA June Air Director call
- June 16th: Participated in a CAPCOA/CEC/CPUC/Governor Office call to talk about impending PSPS and potential for not enough power in California- discussion on protocols, siting of temporary generation, potential for Executive Orders this summer and into 2023/24.
- June 16th: was notified by EPA of a proposed disapproval of our Rule 185 Fee penalty rule that was submitted in 2011. Staff is reviewing, and we will decide appropriate response – which is due by July 18,2022.
- June 16th: MD/AV Fiscal and Transition call many items are moving along and progress is being made on many fronts but still a lot to do.
- June 20th: Submitted MDAQMD second formal comment letter to Federal Register on Good Neighbor Ozone FIP official. MD has forwarded our comment letter (attached with this report) to the sources that will be potentially impacted so that they could coordinate their reviews/comments as well.
