- Sept. 29<sup>th</sup> County of SB Public Health issued a Cease and Desist order to Nursery Products until such time as the correct the deficiencies they identified.
- ♦ Oct. 5<sup>th</sup> Was California Clean Air Day we participated via social media sites.
- Oct. 8<sup>th</sup> Conducted a community project called Clean Air Room Pilot program for Hinkley and Barstow residents only, providing a free air filtration unit to qualifying applicants. Like to thank my staff Jorge, Truong, Martial and Ralph who gave up their Saturday to work the event, and a special thanks to City of Barstow and their staff for helping set up and assistance to make this effort a success.

Administrator for Stationary Sources, US EPA Office of Air and Radiation – I brought up again the Ozone FIP and EPA headquarters broad approach which is troubling (Cement Kilns and Natural Gas Compression are two source categories called out). They plan to finalize by end of March
