- ❖ July marks our 30<sup>th</sup> Anniversary here at MDAQMD and we will have cake after the meeting so stick around.
- ❖ CIP Updates the north parking lot security project is progressing and majority should be done by the end of the month, with some of the electric entrance work maybe taking a bit longer. Solar project replacement bids came in and we are proceeding to review. Also, expect to get a new roof replacement bid, that would take place sometime in future after the existing solar is removed from the roof.

❖ Electric Lawn & Garden Equipment Exchange program update − as of June 19, there has been 691 pieces of equipment exchanged. The program commenced on April 19.

- ❖ The District is currently reviewing applications and preparing for interviews for three positions (2) AQS Compliance, (1) AQE Permitting; and the District is accepting applications (recruitment) for (1) AQS Grants.
- ❖ State Budget Legislature and Administration have agreed on most of the budget (SB101)both Assembly and Senate Budget Committees will hear the budget package today, there will still be some tweaks in the Budget Bill Jr. (AB/SB102) that the Governor will have until the June 30th deadline to sign.
- ❖ A few pieces of legislation updates:
  - AB 985 (Arambula) SJV ERC program Passed with amendments to modify scope of ARB's analysis of SJV's ERC program, still making it through the process may get hearing in Senate EQ first week of July CAPCOA continues to oppose.
  - AB1465 (Wicks) is a tripling of penalties that could be assessed to Title V facilities depending on the violations. Penalty structure has not been modified since 2000. Would set the ceiling, does not mean a district has to assess penalty at the top amount. CAPCOA supports.
  - SB270 (Stern) cities/county may want to track. Requires airports (public or private) that have 50k flights per year to report on how they will meet zero GHG emissions. No criteria on what the report would require, would need to be submitted to CARB, and if CARB doesn't agree on something it could be referred to the air districts. CAPCOA opposes because we have no legal authority over GHG, nor aviation.
